#### **GUJARAT JUDICIAL SERVICE SYLLABUS**

The Gujarat Judiciary Syllabus for the examination of Civil Judge Cadre shall consist of:-

- (1) Preliminary Examination (Objective Type),
- (2) Written Main Examination (Subjective Type),
  - (3) Interview.

## 1. The prelims question paper consists of Parts A, B, and C.

The prelims question paper consists of 100 questions, and each question carries one mark. Out of 100 questions, 75 are in English, and 25 will be in Gujarat. Also, there is a negative marking of 0.33 for each wrongly answered question. The time duration of the prelims exam is 2 hours. You have to score a minimum of 50% marks in the prelims exam to get shortlisted for the mains examination.

- 2. The Negotiable Instruments Act of 1881
- 3. The Indian Evidence Act of 1872
- 4. The Indian penal Code, 1860
- 5. The Gujarat Prohibition Act of 1949

#### Part - B

- 2. The Constitution of India
- 3. The Code of Civil Procedure, 1908
- 4. The Limitation Act of 1963

### Part - C

English Language, General Knowledge, Mental/Numerical/Basic Computer Applications, Test of Reasoning.

- Among the 100 questions, 75 will be in English, and the other 25 will be in the Gujarat language.
- To be eligible for the preliminary exam, you must score at least 50% marks for the main examination.

## 2. Mains Exam Syllabus:

Three papers are in the main written examination: Criminal, Civil, and Gujarati Language.

#### Paper 1 (Criminal)

The total mark of this paper is 75, and you will get 2.5 hours to answer all the questions. Check out the detailed syllabus from the points below:

- 2. Probation of Offenders Act of 1958
- 3. Indian Penal Code of 1860
- 4. Indian Evidence Act of 1872

#### Paper 2 (Civil)

Similar to paper 1, you must answer 75 questions in 2.5 hours. You can expect the questions from the following topics:

- 1. The Limitation Act of 1963
- 2. The Indian Partnership Act of 1932
- 3. The Code of Civil Procedure of 1908
- 4. The Gujarat Court Fees Act of 2004
- 5. The Specific Relief Act of 1963

#### Paper 3 (Gujarati Language)

You will need to answer a total of 50 questions in 1.5 hours. The questions paper is in the Gujarati language.

### 3. Interview

The viva-voce shall carry 50 marks. The main objective of the viva-voce is to assess your suitability for the cadre by judging the knowledge of the Law, the balance of the judgment, mental alertness, clear and logical exposition, attitude, skills, ethics, power of communication, power of assimilation, intellectual depth.

You need to score at least 40% marks in this test to get selected for the Civil Judge post in Gujarat.
