Eligibility for the MP Judiciary, Civil Judge

To be eligible for applying to the post of MP Civil Judge (Jr. Division), a candidate must possess following qualifications-

- 1. Citizen of India, and
- 2. Graduated from a recognized law university, and
- 3. 3 years practice **or** 70 % marks in LLB degree if from general category or 50% if from reserved category.
