- Citizen of India and
- Must hold a degree of law from a recognized college/university
- Must meet the minimum age requirement of 22 years and must not exceed the age of 35

- Age relaxation of 5 years is given to ex-serviceman, SC, ST, OBC; of 15 years to physically handicapped
