- Paper I- Criminal Law for 75 marks, duration – 150 minutes
- Paper II- Civil Law for 75 marks, duration- 150 minutes
- Paper III- Gujarati Language for 50 marks, duration- 90 minutes

### 3. Viva-voce

- This is the last stage of the examination to check the candidate's ability, character and intellectual depth, the power of communication, skills, attitudes, ethics, and balance of judgment.
- Minimum qualifying marks- 40%
