• All applicants who submit applications for the exam are given the opportunity to take the preliminary exam. There are multiple-choice questions on the exam. General Awareness and Law are covered in two papers.

#### Bihar judiciary syllabus 2025: Mains Examination

• The candidates who qualified for the preliminary exam will take the main exam. There are five required exams for the main test and five optional papers, from which each applicant must choose three subjects.

### Bihar judiciary syllabus 2025: Interview Round

• Only a select few will be invited to the interview. The committee appointed by the commission will conduct the interview.

# Bihar judicial services syllabus 2025: Details of the Examination Pattern Bihar judicial services syllabus 2025: Preliminary Examination

- This phase consists of objective type questions.
- There are two sections of the preliminary test for the Bihar judiciary. A multiple-choice (MCQ) test encompassing broad studies and knowledge makes up the first exam that lasts for 90 minutes which is of 100 marks.
- Paper 2 will have 150 total marks and comprise multiple-choice questions on legal subjects that will last for 120 minutes.
- For the general category, a minimum score of 45% is required, whereas for the reserved category, it is 40%.

### Bihar judicial services syllabus 2025: Mains Examination

- This phase consists of subjective type questions.
- The Bihar Judiciary Mains Examination consists of three optional and five required papers.
- There are 1050 points available for the written exam, which are split between descriptive question answers.
- The questions span a wide range of subjects, including general knowledge, current events, Hindi, English, fundamental science, the law of evidence, and general procedure.
- General Hindi and General English are qualifying subjects among the five required subjects.
- In order to move on to the interview stage, candidates need to receive a minimum of 35% overall from these two exams.

#### 6. What is the minimum marks for Bihar judiciary interview?

The commission is going to schedule you for the final examination phase, known as the Personal Interview round if you pass both the Prelims and Mains. One hundred marks are awarded throughout the entire interview. You must get at least 35% in the interview in order to be listed on the final merit list submitted to the Bihar judiciary.

#### 7. How to become magistrate in Bihar?

Prelims, mains, as well as interview rounds make up the selection process. Candidates must pass all three stages to be considered for the final selection. The main test is descriptive; however, the preliminary is objective-based.
