

Chhattisgarh judiciary syllabus 2025

The primary exam-conducting authority that determines the Chhattisgarh judiciary syllabus 2025 and the ultimate selection of Civil Judges in the state is the Chhattisgarh Public Service Commission, which administers the Chhattisgarh Judicial Service Examination for the purpose of hiring judges.

Chhattisgarh judiciary syllabus 2025: Stages of the Examination

Chhattisgarh judiciary syllabus 2025: Preliminary Examination

- The Chhattisgarh Judiciary Online Preliminary Examination, which will consist of 100 objective, multiple-choice questions based on the following state and central statutes, will take place over the course of two hours. Every question will be assigned a single mark.
- Exam questions cover laws such as the Indian Constitution, the Bhartiya Nagrik Suraksha Sanhita, and the Code of Civil Procedure.

Chhattisgarh judiciary syllabus 2025: Mains Examination

- The CGPSC Civil Judge Examination will have a single paper for the main exam. Only those who have cleared the preliminary exam will be eligible to take the Chhattisgarh Judiciary mains exam.
- When evaluating merit, the initial examination is the decisive element. Three hours will be allotted for the major exams.
- There is a maximum of 100 marks available.
- There will be a written, descriptive, and subjective mains examination.

Chhattisgarh judiciary syllabus 2025: Interview Round

- Personal interviews, also known as viva voces, are conducted with the intention of evaluating each applicant based on their distinct attributes. English will be the only language spoken throughout the interview.
- For the CGPSC Civil Judge Exam, there are thirty marks available for the personal interview.
- A face-to-face interview with the applicants who made the short list based on their Main Exam results will comprise the Chhattisgarh Judiciary Examination Viva Voce.

- The Chhattisgarh Judiciary preliminary examination is objective in nature
- There is a 100 mark limit for this exam

- The Chhattisgarh Judiciary mains examination is a Subjective Single paper
- It carries a maximum of 100 marks

- To test the overall personality of the candidate there is an interview round for the Chhattisgarh judiciary candidates who qualify the mains examination
- This interview round carries a maximum of 15 marks

Chhattisgarh judicial services syllabus 2025: Mains Examination

- It includes writing of Judgement and framing of issues in Civil Cases which carries total of 40 Marks
- It includes writing of Judgement and framing of charges in Criminal Cases which carries total of 40 Marks
- It includes translation from English to Hindi which carries a total of 10 Marks

- It includes translations from Hindi to English which carries a total of 10 Marks

Chhattisgarh judicial services syllabus 2025: Interview Round

- A viva-voce will be held, and only a relatively higher number of deserving candidates, based on the number of openings, will be called for the Mains Examination.
- For Viva-voce, the highest possible score would be 15.
- Candidates from the unreserved category must receive at least 33% of the possible points in the viva-voce, while candidates from the Scheduled castes, Scheduled tribes, and Other Backward Classes must receive at least 25% of the possible points.

4. What is the age limit for the civil judge exam in Chhattisgarh?

Those who fall between the ages of 21 and 35 may apply to take the Chhattisgarh Judiciary Examination.

5. Is there any negative marking in Chhattisgarh judiciary prelims?

There are one hundred objective-style questions for one hundred marks in the preliminary examination papers. Candidates have two hours to respond to the questions. Negative marking is not used to the Chhattisgarh Judiciary Exam.

6. Is judiciary exam very tough?

7. Who is eligible for CG judiciary?

A recognized university must have awarded a 3 year LLB or 5 year BA LLB to an applicant. Age Requirement: Applicants must be at least 21 years old and no older than 35. Candidates may be as old as 40 if they identify as OBC-NCL, SC, or ST.

8. What is the gap between prelims and mains in judiciary?

The preliminary results are usually released 20 to 40 days in advance of the Judicial Services Mains Exams. Because of this, candidates start getting ready for the judicial service exams throughout their college years.

9. How to prepare for cg judiciary?

Practice the Question Papers from Previous Years. To acquaint yourself with the format, question kinds, and frequently asked questions of the exam, go over previous question papers. Examine your performance to determine what needs greater attention.

10. What happens after passing judiciary exam?

It is recommended that candidates be appointed to the bench after completing the judicial service examination and the interview. The Indian President makes the final appointment.

11. How to become a judge in Chhattisgarh?

You must be no older than 35 years old and at least 21 years old to apply for the position of Civil Judge. There are exceptions for several groups: women from the SC/ST/OBC/Unreserved categories receive a 10-year extension, Chhattisgarh Temporary/Permanent Workers receive a 3-year extension, and SC and ST individuals receive a 5-year extension.

12. What is the age limit for Chhattisgarh judiciary exam?

For you to be eligible for this recruiting exam, you must meet the minimum age requirement. As of January 1, 2025, applicants for this recruiting exam must be at least 21 years old. As of January 1, 2025, the maximum age to apply for this recruiting exam is 35 years old.

13. How much time is sufficient for judiciary preparation?

You would need about 3000 hours to finish the Judiciary Exam Syllabus because of its length for judicial services tests. About 4000-5000 hours are required if you plan to take additional state judiciary exams. That comes up to three study hours a day, 25 days a month.
