#### Delhi judiciary syllabus 2025

One of the most difficult legal exams in India is the Delhi Judiciary Services Exam 2024. This test, which is given by the Delhi High Court, is open to all Indian nationals who have graduated with a law degree from an accredited university. Prelims, Mains, and Interview are the three stages of the examination selection process.

#### Delhi judiciary syllabus 2025: Pattern of the Examination

#### The Preliminary Examination:

- The mode of the examination is objective in nature

- It carries 0.25 marks of negative marking of each wrong response
- A candidate will only be shortlisted for the Mains exam if they received a score of greater than 60% in the preliminary exam.
- For General and Reserved Categories (scheduled castes, scheduled tribes, and physically handicapped (blind or low vision, orthopedically handicapped, hearing impaired), the minimum qualifying marks for the preliminary exam will be 60% and 55%, respectively.

#### The Mains Examination:

- The DJS Mains exam contain total 4 papers.
  - ➤ The General Legal Knowledge & Language section consists of 250 marks
  - ➤ The Civil Law I consists of 200 marks
  - ➤ The Civil Law II consists of 200 marks
  - ➤ The Criminal Law consists of 200 marks
- This written test is intended to assess the candidate's thorough understanding of various legal topics.
- Subjective and narrative in nature, the main exam will be administered in English, with the exception of the language paper.

#### The Interview Round:

• There will be 150 marks for Viva Voce.

• The Candidate's standing will be determined by the total of both the marks from the Main Examination (written) and the marks from the Viva Voce.

There are two portions that need to be translated: one is to be translated from Hindi to English and the other is to be translated from English to Hindi.

- It might also evaluate your personality, logic, and communication skills.
- Your legal knowledge, comprehension of legal principles, and aptitude for applying them to real-world situations will all be tested by the examiners.
- In order to be considered for a recommendation for an appointment to the Delhi Judiciary Service, candidates in the general category must receive at least 50% of the possible points in viva-voce.
- To be considered for the final selection, candidates in the reserved category need to receive a minimum of 45% of the possible points.
- To get the total for the final merit list, the authorities will add the marks obtained in the main test and the viva-voce.

Candidates for the Delhi Judiciary Exam must be well knowledgeable in a wide range of legal topics because it is a demanding selection procedure. Yes, there is a 0.25-mark deduction for each incorrect response on the Delhi Judiciary Examination. Applicants in the general category are required to receive a minimum of 40% in each written paper and 50% in the total.

### 10. How many hours does a judge work per day in India?

The official work hours are Monday through Friday from 10:30 am to 4:30 pm, including an hour-long lunch break. Generally, Saturdays are off from work. However, the work hours vary and are frequently extended based on the volume of work and number of cases mentioned for a given day.
