- The nature of this stage is qualifying, and the prelim scores are not taken into account for the final selection.

- During the interview, a candidate's capacity for problem-solving and comprehension of diverse socio-legal matters are evaluated.

- The weightage given to one question is of 1 mark
- It contains no negative marking

- The minimum qualifying marks is 90 for general category and the minimum qualifying marks for OBC is 82 for the reserved category

5. What is the lowest rank in judiciary?

The lowest positions in the Indian legal system are held by the Judges of District Courts, Magistrates belong to the IInd Class, and Junior Division Civil Judges.

6. Who is eligible for MP Civil Judge 2025?

These are the requirements for eligibility to become an MP Civil Judge in 2025.

- Educational Requirements: 3- or 5-year LLB degree from any accredited university
- The minimum percentage of marks required for the law program is 70% for General Category and OBC, and 50% for SC/ST Category.
- Age Range: 21 to 35 years old (as of January 1, 2025)
- Nationality: Indian citizenship is required.

7. Is there negative marking in MP judiciary?

Each question receives one mark, and there is no negative evaluation. This is a qualifying exam, and the results are not taken into account for creating the merit list.

8. Can a final year student apply for MP judiciary?

To apply for the Madhya Pradesh Judiciary Examination, you must be an honours graduate in law from an accredited university. In order to be eligible for the exam, you also needed to have passed your final year examination prior to the interview phase.

9. How to prepare for MP judiciary?

11. Is 70 percent required for MP judiciary eligibility?

Today, July 26, the Supreme Court declined to consider a case that contested the necessity of earning 70% of LLB credits in order to be eligible to apply for entry-level positions in the Madhya Pradesh Judicial Services. Such an eligibility criteria, according to the Court, guarantees that better persons enter the judiciary.

12. What is the name of MP judiciary exam?
